CAMPATTERBURY CAMPGROUND RULES

- 1. THE CAMPGROUND SPEED LIMIT IS 5MPH AND WILL BE STRICTLY ENFORCED
- 2. ROADS ARE MARKED AS "ONE WAY ONLY," THE RIGHT TWO ROADS ARE TO ENTER AND THE LEFT TWO ROADS ON THE LEFT ARE EXIT ONLY
- 3. PETS MUST BE ON A LEASH AT ALL TIMES, AND OWNERS ARE RESPONSIBLE FOR KEEPING THE AREA CLEAN
- 4. QUIET HOURS ARE MANDATORY FROM 2200 TO 0700 (10:00P.M. 7:00A.M.) NO GENERATORS OR SIMILAR NOISE PRODUCING EQUIPMENT WILL BE OPERATED DURING QUIET HOURS
- 5. NO VEHICLES WILL BE PARKED ON GRASS. THERE ARE DEISGANTEED PARKING AREAS NEXT TO THE PLAYGROUND, TO PARK EXTRA VEHICLES
- 6. FIREWORKS ARE PROHIBITTED AT THE CAMPGROUNDS
- 7. ALL GUESTS MUST REGISTER WITH THE LODGING OFFICE (BLDG. 402) AND SIGN FOR THEIR KEYS, GUESTS MUST RETURN KEYS TO BLDG 402 ON THE DAY OF THEIR DEPARTURE
- 8. KEYS ARE PROVIDED FOR CAMPERS TO USE THE SHOWER FACILITIES AND REC ROOM
- 9. PLACE ALL TRASH IN PLASTIC BAGS AND DEPOSIT INTO TRASH CONTAINERS PROVIDED AT EACH CAMPING AREA
