1. The Sponsoring Organization agrees to:

- A. Submit this application with a copy of your draft program to NRA for approval.
- B. Provide adequate and suitable facilities to operate the tournament at a level appropriate to a Regional Championship.
- C. Provide sufficient firing points to conduct the Regional within standard time limits.
- D. Provide sufficient trained personnel to conduct the tournament.
- E. Provide awards as specified in the Regional Program Guide for 2017.
- F. Conduct the tournament according to current NRA rules.
- G. Remit the registration fee of \$9.00 per competitor and \$5.00 per team to the NRA within 14 days after the completion of the Regional.
- H. Send a registration card for each competitor or a computer printout complete with NRA membership number, if a member, name, address and score to NRA within 14 days of the Regional. (Portion of SR-1 card showing total number of shots fired and total score).
- I. Send *two copies of the Official Awards Bulletin* to NRA and one copy to each competitor within 30 days after the completion of your Regional.
- J. Complete the Smallbore Distinguished Reporting form, Disregard "x" or center shot count, and include all ties, **for the top 10%.**

2. The National Rifle Association agrees to:

- A. Use proper scores submitted for classification of competitors and send classification cards to individuals, if required.
- B. Recognize properly authenticated National Records established during this Regional.
- C. Furnish medallions, medals and award points as specified in the NRA Regional Program.
