

POLICE TEAM TROPHY

(Formerly Police Team Trophy, New Jersey State Rifle Association cup)



Presented to the NRA by Robert Sever Hale, Team Captain of Light Battery A, in 1900, 1901 and 1902 as a perpetual challenge trophy.

Match Conditions:

- 1965 Teams of two firing members, representing any police department stipulated under "Categories." Both members must represent the same department. No "pick-up" teams will be allowed. No department entering a four-man team will be eligible to enter a two-man team. Course of fire: Modified Practical Pistol Course Match.
- 1966 Added--No department will be permitted to enter more than one team in this match.
- 1967 Sentence added in 1966 changed--No department with more than 50 full-time sworn personnel (Rule 2.4) will be eligible to enter a team in this match.
- 1969 Trophy Put In Competition. Course of fire changed from Modified Practical Pistol Course to NRA National Police Course.
- 1970 Added after above sentence--This ruling must be strictly enforced. All entries will be investigated and teams will automatically be disqualified if found ineligible. Remember that 50 full-time personnel includes such positions as radio dispatchers, I.D. men, correction officers, or jail personnel, etc., if they are sworn officers.
- 1972 Sentences added in 1970 were deleted.
- 1973 Deleted--No department entering a team in Match No. 7 (Four-Man Team) will be eligible to enter Match No. 8 (Two-Man Team).
- 2007 Removed from competition
