**LOCATION:** Winnequah Gun Club is approximately three miles north of Lodi, WI. Take I-90/94 West to Exit 115; turn right onto County Road CS (0.2 mile); turn left at County Road J (1.1 mile); turn right at County Road J at the T in the road (3.3 miles). Look for Winnequah Gun Club sign and Indoor Range on your left. Go through the gate and past the building. Follow the road to the High Power Rifle Stat Office. The club address is: W10219 Larson Dr., Lodi WI 53555. More information is on the club web site. Camping is permitted; the gate will be open by mid-afternoon on Saturday May 31,2025.

**RULES:** Current NRA High Power Rifle OTC. Empty chamber indicators (Rule 3.21) will be available at the range and **MUST** be used by all competitors.

**SAFETY:** If a competitor fails to get on target in **FIVE SHOTS** he/she will be directed to stop firing. Bolts cannot be closed until the rifle is shouldered and pointed towards the target.

**ELIGIBILITY:** Open to all competitors, membership in the NRA is not required. Competitors must be an NRA member to set a NRA National Record. Teams will consist of four firing members, a captain and/or coach. The team captain and/or coach may be firing members of the team. A team captain **MUST** be named (Rule 12.1). Team representation Club-Rule 2.11; Law Enforcement Agency-Rule 2.12; a Regular Service Unit or a Reserve Unit (including National Guard)-Rule 2.13; State Association-Rule 2.12; or Junior-Rule 2.18.

## **EQUIPMENT:**

Individual and Team Matches: Service Rifle – Rule 3.1,3.1.1,3.1.2,3.1.3 (includes .223 Rem) or Match Rifle, Rule 3.3.

# REPORTING TIMES

Check in at Stat Office each day by 7:45 am. Colors 8:05 am, Safety Brief 8:10 am. Firing begins 8:15 am.

#### **AWARDS**

Awards listed in this program are tentative. The on-site Awards Schedule controls all awards. In most cases, awards will be medals, trophy plaques and NRA awards.

#### **REFIRING**

Any refiring will be at a time and place specified by the NRA Range Director or his designated representative.

## **FIRED TARGETS**

All fired targets will remain under control of NRA ELECTRONIC TARGETS

- 1. Electronic Targets will be used in these matches, see Rule 10.17.
- 2. Ideally, ammunition should have a minimum velocity of 1,340 fps at the target, to register on the Electronic Target System.
- 3. Please bring an electronic device with a browser capable of accessing a web page by IP address and enough battery life to last 6-7 hours. A loaner tablet is not available.
- 4. Competitors with Sub-Sonic ammo will not be allowed to fire!
- 5. Rapid fire rounds shall be recorded in the order they were fired. Ties will be broken with Rule 15.4(c) (4)

# **SCOREKEEPERS/VERIFIER**

- 1. All competitors are required to keep score.
- 2. Ties will be broken using Rule 15.4(a) thru 15.4(c)(4).
- 3. In rapid fire, scorekeepers should count the rounds fired by the competitor.
- 4. Scorekeepers should report any missing shots or extra shots immediately.

# **Awards Ceremony**

Friday June,6 2025- approximately 90 min after Cease Fire. DIVISIONS, CATEGORY AND CLASS AWARDS Divisions are separated by Rifle Type as indicated in each Match.

ENTRIES: Individual entries will be made by using the enclosed entry form accompanied by a check or money order. Be sure to indicate your correct NRA XTC classification. Unclassified competitors will compete in the Master Class. IF YOU ARE NOT CHECKED IN AT THE STAT OFFICE 30 MINUTES BEFORE FIRING TIME, YOUR SPOT WILL BE GIVEN TO A PERSON ON THE WAITING LIST.

# **SQUADDING**

NOTE: It is the competitor's responsibility to be present when the assigned relay is called to the firing line. No one will be allowed to set up on the firing line after the end of the 3 minute preparation period.

# 1.Packet pick up/Check-in begins Saturday MAY 31,2025 (PACKET PICK-UP After 12 pm)

- 2. NRA National Championship Squadding will be posted at the Stat office, the morning of each match.
- 3. Competitors must check in at the stat office each morning.
- 4. Competitors must shoot their assigned relay and target.
- 5. Seeded squadding will be used beginning Day 1 of the XTC Championship.
- 6. Re-Squadding: Re-squad competitors will only be for operational reasons, and as directed by the Match Director.
- 7. All special squadding requests should be emailed to ekl@mwt.net by May, 17 2025. Please include details and any necessary documentation such as Medical Waivers.
- 8.A competitor who fails to present himself/herself at the proper firing point when his/her relay is called may lose their right to compete in that event. Competitors must stay on their own relay before firing. Squadding for the Team Match will be given at the Stat Office when registration is completed.

9.Entries must be recieved by May 17,2025

## Rapid Firing procedures

Depending on the amount of entries and not being able to squad every other target. The following procedure will be used when shooting rapid fire. This would be done to alleviate any problems that may arise with the electronics. Complete relay will:

Given 3 min prep period

Given 2 min sighting period

After sighters all EVEN targets will fire their 1st string

While those targets are being scored the ODD targets will fire their first string.

Process will be repeated if a second string needs to be fired.

#### **HIGH POWER TEAMS**

- 1. High Power Rifle Teams will be assigned a single firing point for all team matches for scoring and for competing.
- 2. All NRA Team Matches: Each team must provide one person to score for another team who may be firing or alternate members of that team. A Firing member is a person who has posted a score in that event. NOTE: Everyone on the range is required to process through the Entry Office.
- 3. Team squadding will be assigned when picking up the Team build card and score cards.
- 4. Team Captains should report to the Stat Office 45 minutes prior to the start of the match to ensure paperwork is complete.

# **TEAM REQUIREMENTS**

Teams may enter under the following High Power Category: State Association Teams, Service Teams, Open Teams. Junior State Association Teams may enter provided all firing members are eligible under Rules 2.10 – 2.20. Teams competing under the Open Team category must not be eligible under Service or State Association teams in order to qualify.

# **TEAM ENTRY PROCEDURE**

- 1. Team Captains shall purchase Team cards from the Stat Office. It is the Team Captain's responsibility to purchase the correct Team Card. Entering and firing in the wrong match will be disqualified.
- 2. Team entries close at 4pm the day before the match Tues June 3 2025.

#### **INDIVIDUAL and TEAM AWARDS**

NRA Awards are issued based on the number of authorized firing members. When provided for by the match award conditions, plaques or medals will be awarded to each individual or firing member of the team and the sponsoring club or organization, if applicable.

<u>COURSE OF FIRE:</u> Shotmarker Electronic Target System will be used for scoring. Competitors will be required to score/verify. Please bring a spotting scope or binoculars for verifying all shots fired on the target. Failure to do score/verifying duties may result in a DQ.

## WARM UP MATCH Fired June 1, 2025
