If a competitor opts-out of W9 verification, they will be forfeiting any potential monetary awards for the Championship. The W9 opt-out selection is irreversible if not completed by the close of Registration.

SQUADDING

Individuals shall be squadded at the discretion of the Championship Officials. Competitor packets will include squad sheets detailing competitor firing times and dates for each event. Squad requests will be accommodated if at all possible until April 30. Any requests may be made via email to bianchicup@nrahq.org.

INDIVIDUAL DIVISIONS

Competitors will be divided into three (3) divisions per Section 2 of the NRA Action Pistol Rules. Competitors may not change from one division to another during any phase of the Championship. This division will be used for all events and is different from the division used for the Multi-Gun match.

INDIVIDUAL CLASSIFICATION

All competitors who do not hold an NRA Official Classification, in the type of competition being fired or an Assigned Classification according to NRA Action Pistol Rules 19.6, 19.16, and 19.17, will be placed in the Master class. NRA Action Pistol Rule 19.14 may NOT be used but NRA Action Pistol Rule 19.6 may be used. The Tyro designation will not be used.

JUNIOR COMPETITOR ELIGIBILITY

Individuals may compete as juniors in either Individual or Team competition at the NRA Championships, provided they meet the following criteria in NRA Action Pistol Rules 2.3, 2.3.1 or 2.3.2.

ADULT SPONSORS, JUNIOR ENTRIES

All Juniors aged 17 and under, must be accompanied by an adult sponsor. An adult sponsor is defined as a person 21 years of age or older. The adult sponsor is responsible for the behavior and welfare of those individuals sponsored.

MULTI-GUN DIVISIONS

Competitors may register in the Multi-Gun Match as an individual under a different division than the division used during the Championship. A second firearm not used in the main championship will be inspected for use in the Multi-Gun Match. See Section 3 of the Action Pistol rulebook for details.

GUEST ENTRY

Competitors may register guests to observe the Championship and attend the Awards Banquet. Guests must comply with the event dress code.

TEAM ENTRY INSTRUCTIONS

There are 4-Person Open Teams and 2-Person Metallic, Production, Woman, Junior and Senior Teams. Team Captains are requested to purchase team entry cards on-line and do not need competitor information to do so. Team Captains will finalize team entry cards at the Registration Office prior to the close of registration.

Completed forms will include the team name, Team Captains name and competitor numbers. Disqualified teams will not be reimbursed entry fees.

TEAM ELIGIBILITY

Teams may enter under the following NRA Action Pistol Rules 2.10 -2.14, and 2.19. Team members cannot be firing members of a more than one (1) team.

TEAM CATEGORIES

Teams will be divided into 6 categories. Competitors may not compete in more than one category.

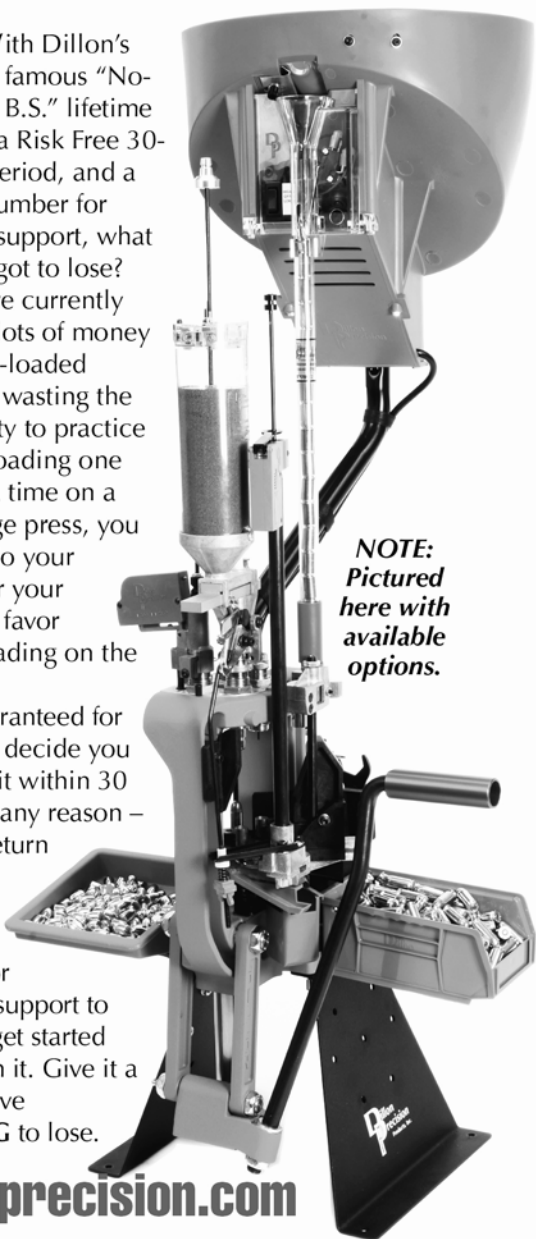

TOURNAMENT CONDITIONS

RULES

Current NRA Action Pistol Rules will govern the conduct of the Championship except as modified within this program. Check the Match Director's Bulletin for any modifications of firing conditions. All competitors are responsible to be knowledgeable of all rules, regulations, and contents of this program. See NRA Action Pistol Rule 18.2.

Everyone involved in the Championship must understand that in accordance with NRA Action Pistol Rule 11.1 and 11.4, the NRA Match and Range Directors have complete authority to make any changes they deem necessary in order to ensure that the competitions are run smoothly and safely. This may include changes in relay and squadding schedules and cancellations of firing altogether. Any such changes will be relayed to the competitors via announcements and/or Match Director Bulletins.

OFFICIAL BULLETIN BOARD

The Official Bulletin Board is located outside the Statistical Office inside the clubhouse. Preliminary bulletins on all matches and all official notices will be posted on the Official Bulletin Board. Competitors are reminded that it is their responsibility to check the Official Bulletin Board for official notices and scores. See NRA Action Pistol Rule 18.13.

FIREARMS ALLOWED

See NRA Action Pistol Rules Section 3. Firearms on the range must be in a holster or case. Substitution of pistols (except under provision of NRA Action Pistol Rule 9.1 will result in disqualification.

FIREARMS INSPECTION

Firearms inspection will occur at the Range. Pistol triggers will be subject to random checks on the firing line. See NRA Action Pistol Rules 3.2.2, and 3.4.

HOLSTERS

Competitors may not use holsters that violate safety considerations, such as shoulder, chest, and other such designs. See Section 3 of the Action Pistol rulebook for details.

AMMUNITION

The competitor shall bring sufficient ammunition to fire each event, including any potential re-shoots, tiebreakers, function test firing, and Chronograph testing. Each competitor will provide a sampling of ammunition from a magazine, speed loader, or bag upon request of a Championship Official during the Championship for testing at the Chronograph. Failure of ammunition to conform to the standards established in NRA Action Pistol Rule 3.17 will result in

disqualification. Fired brass that falls to the ground shall become the property of the NRA.

GROUND COVER

The range shall provide ground cover (i.e. shooting mats).

GLOVES

Gloves may be worn which do not form artificial support. You must wear the glove(s) during the whole event. See rules 3.11, 3.18, and 5.2 in the Action Pistol rulebook for details.

POSITIONS

It is the competitor's responsibility to assume the correct ready position and maintain a proper firing position during each event. See NRA Action Pistol Rule 5.3 and 5.12 for more details.

FIRED TARGETS

All targets are the property of the NRA and shall not be removed nor retained by the competitors.

PENALTIES

Range Officers will issue no warnings regarding faults before or during an event.

SCORECARDS

Scorecards are provided to each competitor in their packet. All scorecards and team cards used in the matches must be labeled with self-adhesive labels supplied in each competitor's packet. Make certain that you place your labels on your scorecards before you go to the range. Competitors who appear at the firing line without scorecards will be required to purchase substitute scorecards at a cost of \$5 per scorecard. It is the competitor's responsibility to have the correct change.

When signing scorecards, the competitors must remember they are signing for the value of each shot indicated on the card. Each competitor is responsible for their scorecard. See NRA Action Pistol Rule 18.14.

SCORING

Scoring in events I, II, and III will take place in the Central Scoring Area. Competitors must report to the area thirty (30) minutes after they complete an event to review targets and scorecards. If the competitor agrees to the score, they will sign the card. Competitors must review targets no later than thirty (30) minutes prior to the conclusion of that days firing. Targets will not be available for review the following day. Scoring in event IV will take place at the rear of the stage. Steel must fall to score.

USE OF SCORING DEVICES

The use of the plug-type scoring gauge will be restricted to use by Official Referees only.

TIES

In events I, II, and III ties will be broken following NRA Action Pistol Rule 15.2. In event IV, ties will be broken following NRA Action Pistol Rule 15.12.

CHALLENGES

If a competitor feels that a shot fired by himself or by another competitor has been improperly evaluated or scored they may challenge the ruling.

CHALLENGE PROCEDURE

The competitor must make the challenge prior to signing the scorecard. If it is another competitor's target, then the competitor must make the challenge at least thirty (30) minutes prior to the conclusion of that days firing.

CHALLENGE FEE

Upon sustaining the competitors challenge, the challenge fee will return to the competitor. Upon rejecting the competitors challenge, the challenge fee will add to the general revenue of the Championship. The decision of an NRA Official Referee shall be final. See NRA Action Pistol Rule 11.2 and Section 16 for details.

PROTEST PROCEDURE

A competitor must initiate a protest immediately upon the occurrence of the protested incident. Failure to comply with the following procedure will automatically void the protest:

- State the complaint orally to the Chief Range Officer. If not satisfied with the decision then,
- State the complaint orally to an Official Referee. If not satisfied with the decision then,
- Obtain a protest form from the Chief Referee; complete the protest in writing stating all facts of the case. File the protest with the Chief Referee within two (2) hours of the protested incident. A protest fee of \$100.00 must accompany the written protest.

- The Championship Protest Committee will call a meeting to rule on the protest. The protesting competitor should be prepared to appear before the Protest Committee if requested to do so.
- Decisions made by the Championship Protest Committee are final.

Upon sustaining the competitors Protest, the protest fee will return to the competitor. Upon rejecting the competitors Protest, the protest fee will add to the general revenue of the Championship. See Section 17 for details.

PROTEST COMMITTEE

A decision of the National Championship Protest Committee is final but may not override a prior decision of the National Protest Committee. See NRA Action Pistol Rule 16.2.1.

MATCH CANCELLATION BY MATCH DIRECTOR

If the Match Director cancels any match, entry fees will not be refunded. In the event that a match is canceled, the Match Director may reschedule that match. It is the competitor's responsibility to bring ample ammunition should this happen.

COACHING

No person may coach another during the events in the Championship, which are individual in nature. See NRA Action Pistol Rule 9.10 and 12.2 for details.

WEATHER

The Match Director may, at their discretion, cancel, extend, or alter the course of fire due to inclement weather or for any other reason considered worthy. It is the competitor's responsibility to remain in the immediate vicinity of the range and to be ready to resume shooting as soon as it is safe to do so. Weather delays, if necessary, will occur in fifteen (15) minute intervals.

OFFICIAL TIMING

In events where turning targets are used, time is taken for the period during which the target is fully exposed. Time is not checked on each individual shot but is computed on the indicated allowance for each string depending on the type of fire being conducted.

The official timing device in event IV will be an electronic timing device, which actuates the plate- locking bar. In the event a target systems breaks down, the official back-up system will be a sound actuated electronic timing device.

The official time is Central Standard Time. The Range Director will keep the Official Match Time.

FIRING TIMES

Firing will begin daily at 8:00 am CST. Competitors shall report to and remain in the staging area provided at each firing range at least fifteen (15) minutes before their assigned firing time. Fifteen (15) minutes prior to the assigned firing time a Range Officer will announce the competitors' first call. Ten (10) minutes prior to the assigned firing time a Range Officer will announce the competitors' second call. Failure to check-in by the second call will result in disqualification for the event.

COMPETITOR MEETING

Those members of the Action Pistol Committee of the NRA who are present during the Championship will meet to discuss NRA Action Pistol Rules only. All NRA members are encouraged to attend and to contribute to the proceedings. See the Schedule of Events found in this program for the location, date, and time.

DISQUALIFICATIONS

Any safety violations as described in Rules 9.16, 9.17 and 9.17.1 that occur on the range at any time during the Championship will lead to disqualification of that competitor from the entire Championship.

Dropping an unloaded firearm is not sufficient reason for disqualification. Competitors are cautioned not to pick up dropped firearms unless under the direction of a Championship Official.

Dropping of an unloaded firearm and picking it up without the direction of a Championship Official comprises two (2) safety violations and is reason for disqualification.

Dropping a loaded firearm at any time during the Championship shall result in disqualification of the competitor for the entire Championship.

CLASSIFICATION

All event scores will apply for NRA Classification purposes. NRA Action Pistol Rule 18.4 Classification will be in effect. See NRA Action Pistol rulebook Section 14 for details.

NATIONAL RECORDS

Competitors who complete an event with a score of 480-48x will have an opportunity to set National Records. NRA will recognize National Records over courses of fire as outlined in the NRA Action Pistol rulebook Section 17.

CHAMPIONSHIP MATCHES

NRA NATIONAL ACTION PISTOL CHAMPIONSHIP

The NRA National Action Pistol Championship is a Squadded Individual Match that will occur over two (2) days. Competitors will fire no more than two (2) events in any one (1) day. See NRA Action Pistol Rule 1.7 (h) for details. The Championship will consist of the aggregate scores from the following four (4) events: Practical, Barricade, Falling Plate, and Mover (Modified). The highest possible score is 1920 – 192X.

MULTI-GUN MATCH

The Multi-Gun Match is an Aggregate Match that will occur over three (3) days. See NRA Action Pistol Rule 1.7 (m) for details. The match will consist of four (4) aggregate scores from the Multi-Gun match day as well as the four (4) aggregate scores from the championship. All four (4) events fired on the Multi-Gun match day must be a different division than all four (4) events fired on the two (2) championship days. The highest possible score is 3840 – 384X.

TEAM MATCH

The Team Match is a paper match that will occur during the Championship. Each member of a four (4) person team will contribute to the team aggregate from only one (1) of the four (4) events. Each member of a two (2) person team will contribute to the team aggregate from two (2) of the four (4) events. Team members must declare which event will score for each team member prior to the close of registration. The highest possible score is 1920 – 192X.

AWARDS

In the spirit of "Good Sportsmanship," competitors must be present at the Awards Banquet to accept any awards or prizes. Champion award winners are not eligible for category, class, and event awards.

The following awards will not be mailed: medals, trophies, plaques. All awards must be picked up from the Awards Office before departing the event. Prize Table Awards not claimed immediately following awards banquet will become property of the NRA.

Citizens of any country may win the Championship, except by those whose countries restrict participation and winning their Championship to their own citizens.

The winners, US Citizens and International, shall be solely responsible for all fees related to the transfer of any awards and/or prizes, including but not limited to possible license fees, transfer fees, handling fees, background fees, and/or shipping fees. The handling of all awards and/or prizes shall have reasonable security.

The NRA and Championship Officials shall assume no responsibility whatsoever for the transfer or transportation of any award, for the legal compliance of such transfer or transport, or for the loss, theft, or damage of same.

MONETARY AWARDS

W9 information will be electronically collected and automatically verified during the registration process through a secure verification website. Registration cannot be finalized without filling out the requested information and verification being completed, or selecting the opt-out option.

If a competitor opts-out of W9 verification, they will be forfeiting any awards of monetary value for the Championship. The W9 opt-out selection is irreversible if not completed by the close of Registration.

Awards checks will be mailed from NRA Headquarters, in Fairfax, VA after the conclusion of the Championship. All winners must sign for awards and/or prizes and receive official redemption documentation. The National Rifle Association continually strives to achieve full compliance with all tax laws and regulations. NRA Financial Services conducts a review of all NRA competitions where a tax event might occur. A tax event occurs when a competitor wins a total amount of at least \$600 in cash or merchandise. An IRS Form 1099- Misc is issued to all competitors whose total winnings are at least \$600 in a calendar year, regardless of the age of the competitor. Should you have questions please call NRA Finance at 703.267.1652.

TROPHIES

Competitors who win trophies will receive them at the awards ceremony.

FIREARMS AWARDS POLICY

The NRA and Championship Officials shall assume no responsibility whatsoever for the transfer or transportation of any award, for the legal compliance of such transfer or transport, or for the loss, theft, or damage to same.

Competitors may not sell or trade firearm awards. In cases where the winner may not legally claim a firearm prize, or otherwise is ineligible, an appropriate substitution may occur if substitution prizes are available.

It is the policy of the Championship not to award firearms to junior competitors that are not of legal age to receive the firearm directly from the FFL holder.

INTERNATIONAL COMPETITORS

International competitors will be exempt from the electronic W9 collection process. They will be required to complete a form W8 at Registration and will be taxed 30% on awards regardless of amount won. Trophies, plaques, and registration materials are exempt from this tax.

AWARDS BULLETIN

Preliminary awards bulletins will be posted outside the statistical office at the range. An official copy of the final results will be available on-line at <https://competitions.nra.org/results-and-records/national-matches-results/>.

INDIVIDUALS

Individuals receiving first, second, or third place awards are not eligible for class and category awards but are still eligible for special category awards in the same event.

There must be five (5) or more individuals in order to establish place or class and category awards. If there are fewer than five (5) competitors within a class or category, they will be combined within the class or category as shown below until a total of five or more is achieved. In no case will any competitors of a lower classification be combined with the Master class or the High Master class.

JUNIORS

There must be five (5) or more juniors in order to establish place awards. If there are fewer than five (5) juniors, competitors will be combined as shown below until a total of five or more is achieved.

HEARING IMPAIRED COMPETITORS

It is the responsibility of competitors who are hearing impaired to inform the Range Officer each time they go to the firing line.

AUTHORIZED ASSISTANCE

Individuals who have a physical disability, may have someone assist them in moving equipment to and from the firing line.

MEDICAL EMERGENCY

Report any medical emergency immediately to the Championship Officials or range personnel.

LOST AND FOUND

The lost and found is located at the Statistical Office. It is strongly suggested that all personal items be permanently marked so easy identification can be made if lost. At 5 pm Friday, all lost and found items will be moved to the hotel.

VEHICLE PARKING BAYS

Parking near the bays will not be allowed except for vehicles displaying a current handicapped sticker or "Range Vehicle Pass" which may be obtained from NRA Headquarters Statistical Office. Range vehicle passes are not transferable and must be returned to NRA Headquarters when no longer needed.

OTHER AREAS

Competitors may park in the lot located at the third range entrance. Match Staff parking is available at the second range entrance behind the scoring shack. Overflow parking is available at the first range entrance.

SAFETY

All competitors will observe firearms safety practices.

EYE AND EAR PROTECTION

Everyone is required to wear eye and ear protection in and around the firing line. Eye and ear protection are available for purchase in the Vendor area.

ALCOHOL AND NARCOTICS

Consumption of any alcoholic beverage or narcotic substance, which can alter the normal mental or physical function of the body, either on the range or in the spectator or public areas while the ranges are in use, is prohibited.

The use of any narcotic substances anywhere on the range is prohibited. Disorderly conduct or intoxication is not permitted on the range or on any contiguous range property. A person who violates this regulation will be subject to immediate disqualification and expulsion from the Championship with no return of entry fees.

PROPER ATTIRE

In keeping with the tradition established by NRA in shooting events, and recognizing the publicity attracted by the Championship, it is important to promote an acceptable image for competitive shooting. Attire worn during all phases of the Championship should be in good taste and appropriate to such a prestigious sporting event. Articles of clothing with controversial or offensive slogans or illustrations are prohibited.

It is strongly recommended that articles of clothing be worn that will ensure the comfort and safety of all competitors and range personnel.

The Match Director is empowered to take whatever action is necessary to maintain acceptable clothing standards. Weather in Missouri is quite variable. Clothing for hot, cool, and wet conditions should be brought.

Competitors will wear the competitor bib number provided in the competitor packet on their shirt back, in full view while competing in the Championship. The competitor forfeits assigned time slots for any event in which the bib number is not in full view.

Semi-formal attire is appropriate for the NRA National Action Pistol Championship award ceremony. The competitor forfeits their entry to the award ceremony if not dressed accordingly.

CONDUCT

Good sportsmanship, professionalism, and safety are important principles of the sport of pistol shooting and shall be requirements for attendance or participation in the Championship.

Any person who is unable to act accordingly shall be instructed to leave the range and may be disqualified from further participation in the Championship and its associated events. See Section 9 in the Action Pistol rulebook for details.

FUNCTION RANGE

A twenty-five (25) yard range with targets will be available for function test firing only. This range is located on bay five (5). Range Officers will be present during the Championship to administrate its operation. To utilize the range, the competitor must be under direct supervision of a Championship Official, Chief Range Officer, or Range Officer.

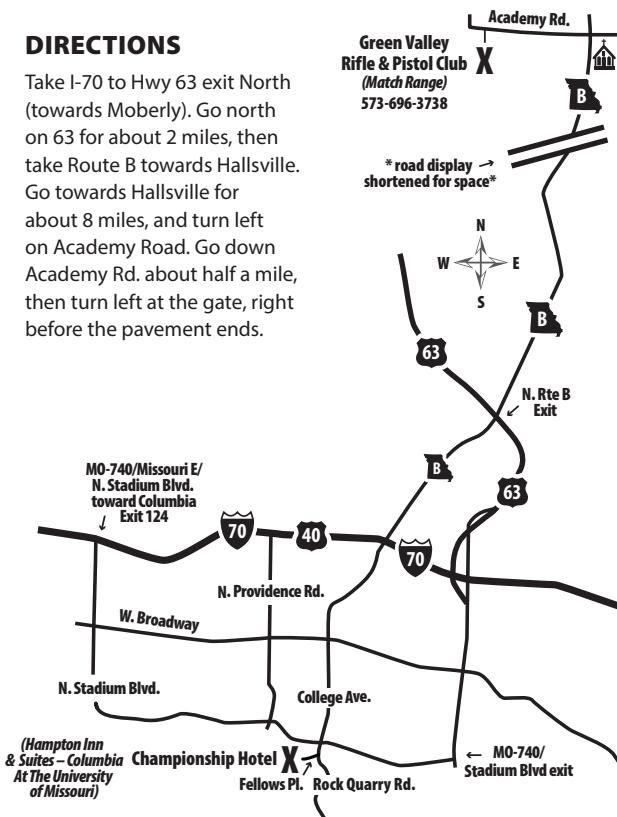

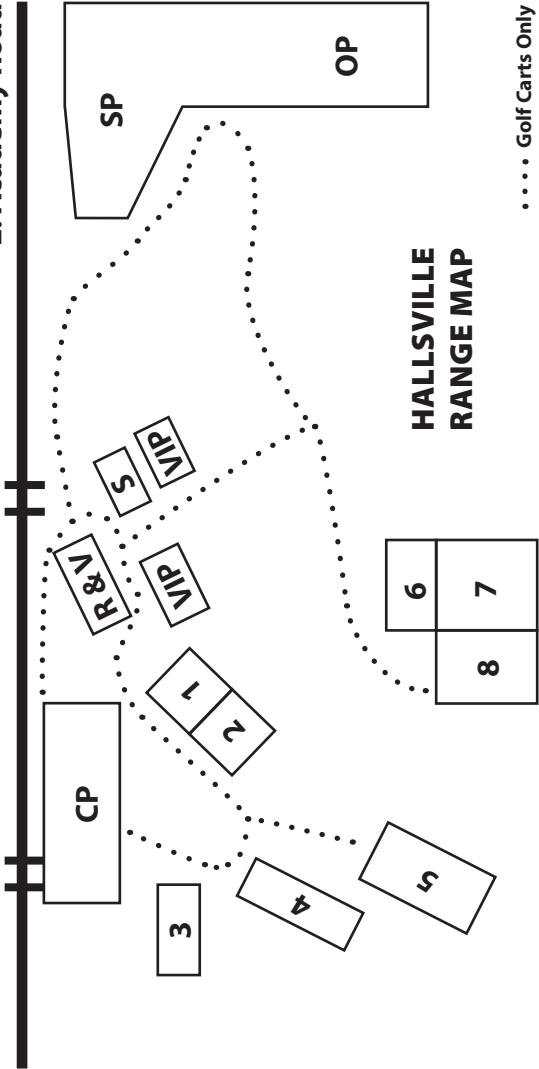

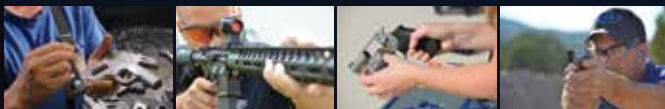
